The Local Picture Postcard Page Part 231 By Alan Winter

St James Church – Hampton Hill

I thought we would have a look at the origins of St James Church as it has a very interesting and probably unusual history.

Our first postcard shows the church and graveyard as it was in the 1920's. This is followed by one of the interior from the same period and finally an excellent postcard of the Lych Gate.

So, on with its history.

What was to become Hampton Hill was originally



the southern corner of Hounslow Heath, used as common land to graze animals. It was a haunt of highwaymen and footpads, with a gibbet for the punishment of these criminals on the corner at the Hampton Hill end of Burton's Road. The Commons Enclosure act of 1811 allowed parts of this heathland to be enclosed and the land, which is now between St James's Church and Hampton Hill High Street, was converted into glebe (land providing income for a clergyman) for the benefit of St Mary's Church, Hampton.

During the early 1860s the Thames Valley Railway Line was extended, the Hampton Water Works were built and the local nursery trade developed. These projects brought an enormous number of rowdy, hard drinking labourers and artisans into an area with terrible conditions, many people living in *"miserable hovels"*. They helped to increase the number of public houses in the district to thirteen, these being the scenes of not a few *"public affrays"*. The Common, as the area was then called, was described as *"a miserable area inhabited by an even more miserable brand of people"* and the little district chapelry of St James as *"a barn of a church in a wilderness of a parish"*. There were no facilities or services in the area and consequently poverty, drunkenness and violence were widespread. The shacks in which these people lived gradually developed into a community on the common and it was described as *"a wilderness with a number of habitations of the most wretched kind, inhabited by a still more wretched class of people"*.



The Revd James Burrows, MA, was appointed vicar of St Mary's, Hampton, in 1861. Within a year it was decided that a new church, the District Chapelry of St James, should be built to cope with the appalling situation and serve the scattered village of New Hampton situated a mile or more away on the hill above Hampton. The mother parish of St Mary's gave some of its glebe land for this purpose and a simple church, with a

nave, a chancel and a small vestry room, was built. When it was finished Revd Fitzroy John Fitz Wygram was appointed vicar, and the building was consecrated on December 11th, 1863, by Bishop Tait, Bishop of London.

Revd Fitz Wygram and his wife devoted their lives and much of their fortune in improving the living conditions and prospects of the parishioners. Consequently, matters speedily



improved and people started flocking to worship in the little church.

This was the beginning of twenty years of additions and alterations which changed the simple village church into the building we know today. In 1874 a new organ chamber and vestry were added and an organ was purchased by the Vicar for the sum of $\pounds150$.

The work was again dedicated by the Bishop of London on Friday, July 18th, 1879. All seats in the new aisle were entirely free, while in the rest of the building they were reserved until the commencement of the Psalms.

The year 1887 being Queen Victoria's Golden Jubilee, it was proposed to commemorate the event by the building of the Tower and Spire, so completing the Church. So, by the enthusiasm and generosity of the parishioners who had found most of the money needed, the church was built in thirty years and with surprising detail. The view from the top, on a clear day, extends as far as Henley, Harrow, Highgate and Boxhill and beyond.

The Churchyard originally comprised only the area which immediately surrounded the church; the cemetery at Hampton still serving the new parish. In the light of the growing population of the new parish this was found to be unpractical and in 1882 the vicar of Hampton gave an acre of land adjoining Park Road to be used as the parish burial ground.

During the Second World War St. James's narrowly escaped destruction when one of our own planes, returning from a raid over Germany, crashed on to No. 63, Park Road, the home of Lady Stanton. The only trace remaining of the incident is the absence of the cross at the top of one of the tower pinnacles, which was removed by the plane's wing-tip - so close was St. James's margin of safety!

Electric lighting was installed in 1905 and the organ was rebuilt in 1913 and again in 1951.

Today **The Parish Church of St James at** 46 St James's Road, Hampton Hill, Middx. TW12 1DQ is in good shape to face its future.

Transport and Air Quality Committee

Transport and Air Quality Committee

Tuesday 9th January 2024

This was the first council meeting of 2024 with the first item on the agenda being the Ward Concern raised by Cllr Laura O'Brian about rat-running on the Riversmeads Estate next to Twickenham Golf Course. The Committee agreed to investigate traffic calming measures despite not reaching the newly agreed intervention criterion.

Next up was the **Air Quality Management Plan**. Most areas of the borough were meeting national air quality targets, apart from two locations in the borough. They decided to instruct officers to prepare a report that would adopt the new interim World House Organisation (WHO) targets for air quality and concentrate on tackling pollution from traffic and aligning policy with the active travel agenda. Cllr Alexander Ehmann warned these would be very hard to meet and would need the assistance of the council partners and that car use would have to be reduced.

The **Hospital Bridge Road segregated cycle lane** for Turing House School was then discussed. 53% of respondents to the council consultation were against having a segregated cycle lane, but the council decided to go ahead anyway on the first section between Percy Road and Springfield Road in Whitton. The scheme will see around half of the car parking removed from the street and a resident asked if the council could consult on a CPZ.

There was then an update on **ULEZ** which had recently been extended to outer London. Cllr Ehmann criticised the Conservative Councils who mounted a legal challenge in the courts saying it was just a waste of money. He said the administration had decided to put what would have been the council's contribution to the court case into additional relief measures such as free car club memberships and money loaded onto Oyster Cards for those who scrapped their non-compliant cars. He then went political and started to criticise the Conservative Prospective Parliamentary Candidate Jonathan Hulley for visiting the anti-ULEZ protest on Chertsey Road in December. He said that it was "appalling" that vehicles were idling and parked up on verges and the honking of horns was "dreadful." The video Jonathan made went viral attracting over a quarter of a million views.

A discussion was held on how bus services could be improved as large areas of the borough have a low PTAL rating (Public Transport Accessibility Levels) and the expected **bus service improvements** before the ULEZ expansion has not materialised. The committee agreed to raise the issue of bus services will be brought up at the next Public Transport Liaison Committee where councillors meet representatives of public transport providers. Unlike most other councils, Richmond holds them in private and does not publish the minutes.

The next item was the **highway maintenance program** which will see 20 carriageways resurfaced and 31 footways repaired. Regarding HS2 money redirected to fixing roads, Cllr Alexander went back into political mode and said that "any resident mad enough to be listening, we expect to receive a meagre £200,000". The TRT Tribune has investigated this, and the funding is based on the length of roads each borough maintains with Richmond due to receive an extra £6.2 million over the next 11 years with £204,000 allocated for each of the next two years.

Next up was the **Local Implementation Plan** (LIP) indicative funding for 2024/25 from Transport for London with Richmond set to receive £1,023,000 for Safer Corridors and Neighbourhoods, £76,000 for cycle training, £54,000 for cycle parking. The council can also bid for up to £277,000 for bus priority measures and £700,000 for cycle network funding. Tim Lennon from Richmond Cycling Campaign spoke and said the council needed to provide more safe places for cyclists to leave their bikes and not all the funding should be going to cycle hangers. He said there was a need for more located by shops, doctors' surgeries etc. He gave the example of the Sheffield stands outside of Tesco's in Richmond town centre that were damaged and not replaced. Cllr Andrée Frieze asked for more bike stands down Church Street Twickenham and the committee decided to ask officers to report back on options to provide more Sheffield stands across the borough.

There was a brief discussion on the forward plan, to decide when future items on the agenda would be discussed and the meeting closed at 9.45 pm.

Council fines have-a-go hero

Richmond Council are refusing to back down and cancel a £130 fine they issued to a have-a-go hero who was pursuing a shoplifter.

The incident took place last October outside Sainsbury's Local on Twickenham Green, when Mr Norman Brennan saw a man being chased by a security guard. He followed the suspect in his car to an industrial estate and performed a citizen's arrest. A backpack was also recovered with nine bottles of wine that had been taken from the store without payment.

A few days later Richmond Council sent out a fine in the post for driving down the road the wrong way. Mr Brennan wrote to the council asking them to waive the fine but rejected the appeal saying, 'while I appreciate you were following an alleged shoplifter, you had no legal authority to enter this road.' Mr Norman Brennan told the Mail on Sunday; 'I was staggered by the response from Richmond – cold and dispassionate and lacking any common sense. Surely they could have exercised discretion.'

To make matters worse, despite having all the evidence and a suspect the manager at the store decided not to press charges. As explained at a local Police Liaison Committee meeting in December, the MET now requires businesses that want to press shoplifting charges to fill out reports themselves before an officer is assigned to investigate and this results in most cases being dropped as the staff often don't have the skills or the time to complete themselves.

Mr Brennam is a well-known commentator on policing matters and was an independent candidate for the role of Dorset Police & Crime Commissioner in 2021. He served in the police force for 42 years, has spoken publicly about law and order for 29 years and has spent 16 years campaigning for police and victims having set up the Victims of Crime Trust and the Law & Order Foundation.

In October 2023 the Crime and Policing Minister Chris Philip MP told a fringe meeting at the Conservative Party Conference that 'The wider public do have the power of citizen's arrest and, where it's safe to do so, I would encourage that to be used because if you do just let people walk in, take stuff and walk out without proper challenge, including potentially a physical challenge, then again it will just escalate. While I want the faster and better police response, the police can't be everywhere all the time.'

However, how many people will be willing to do the right thing and stop a thief if public bodies like Richmond Council take such an inflexible approach which results in the highly unsatisfactory situation where the criminal gets away scot-free and the hero ends up with a fine? This sounds like a case where the leader, Cllr Gareth Roberts needs to intervene if he is to retain his credibility on policing matters.

A 'Fine' Way to Treat Good Samaritans.

This week's news that retired police officer Norman Brennan has been fined by Richmond Council for doing the right thing is yet another example of how the *'Best borough in London'* treats people.

Mr Brennan, a former British Transport Police detective, has been honoured numerous times for bravery. Described as one of the best-known voices of British policing, he founded the Victims of Crime Trust whose patrons include Denise Fergus, the mother of murdered toddler James Bulger, and launched Protect the Protectors which successfully campaigned for police to have side-handle batons, body armour, and CS spray.

A hard-hitting campaign by the Mail on Sunday has exposed Britain's shoplifting scandal and called for tougher action, revealing how the crisis costs stores £1billion a year – for which YOU pay. Similarly to Mr. Brennan, I recently received two fines from Richmond Council for being a good Samaritan. To save the NHS ambulance service time and money, I drove a profusely bleeding injured neighbour to Teddington hospital where I parked in a quiet side road which had NO road markings and NO visible signs for parking restrictions. On my return, I'd received a parking fine. My appeal to the Council on all the above grounds was bluntly rejected.

The other occasion was near Strawberry Hill station, also on an unmarked road, when I took my wife to hospital for breast cancer surgery. In order to help Richmond Council's professed but unenforced dogma to reduce traffic congestion and pollution, we made a difficult journey by train, bus, and taxi, so as to avoid driving all the way. On our return, I had a parking ticket. The Council refused my appeal with a statement falsely giving a map reference for a sign showing parking restrictions. No such sign exists there.

Maybe the Council's avaricious bullying is to raise money for the recent increases in its councillors' allowances, including its Leader's massive one of 52%, as highlighted recently in the Tribune?

Some time ago, I was passing the Sainsbury's St Clare store when I saw their security guard unsuccessfully struggling with a man on the pavement. I was a special constable at the time but off duty, so, having spent my life training in both classical and modern martial arts in Japan, I stopped my car and easily restrained the thief. I called the police and received a commendation from the police commander for my actions. No doubt, had it been more recently, I would have received a fine for my trouble, just like Mr. Brennan.

British law embodies the principles of *mens rea and actus reus* with their assumption of innocence until <u>proven</u> guilty, and the legal defence of *necessity*, all of which are now clearly ignored in the pursuit of money. With the Council showing such lack of compassion, and acting as judge and jury, we should all be grateful we don't still have the death penalty.

So why bother to be good Samaritans only to be treated worse than the criminals who get away with it?

Break In At The Twickenham And Richmond Tribune

The "burglars" entered at 21.17 on Tuesday 9th January via the front door leaving at 21.49. The police are perplexed; they said this was not the usual breakin and had not seen anything like this in 20 years of service; everything had been undisturbed apart from a box of files and the front door.

Social Media Watch

This week on X (formally Twitter) Richmond Council **leader Cllr Gareth Roberts** got into a spat over criticism of **Sir Edward Davey's** parliamentary no-show and was promptly blocked. Cllr Roberts did not take kindly to this and snapped back that she cannot "accept even lightest criticism." The irony is that Cllr Roberts pre-emptively blocks any resident from replying to his tweets unless they are one of his pre-approved followers.

For readers who have been out of the country the past week Sir Edward Davey, the Leader of the Liberal Democrats has been widely condemned for dodging parliamentary scrutiny for his role in the Post Office Scandal and has been facing calls to hand back his knighthood. The Post Office scandal rocketed up the agenda after the ITV drama Mr Bates vs The Post Office was broadcast on New Year's Day. Sir Edward was the Post Office Minister between 2010 - 2012 and was subsequently paid £275,000 as an adviser to the legal firm that defended the Post Office against claims of wrongful prosecution. Sir Edward claimed his care arrangements for his disabled son broke down which meant he could not attend the debate.

The Kingston Independent Residents Group are considering putting up a candidate against Sir Edward at the next general election in the mould of Martin Bell. New Maldon **Councillor Yvonne Tracey** and a former deputy post mistress said it was "...it's incumbent on those seeking justice for our sub-postmasters to stand against Ed."

This is likely to have ramifications for Sarah Olney MP and Munira Wilson MP as both are reliant upon activists from outside the area campaigning on their behalf at General Elections. If a 'white suit' candidate is fighting the party leader's seat this outside help is likely to be redirected to his constituency at the expense of theirs.

Double Trouble for Local Motorists

Two problems inconvenienced motorist in Twickenham this week. High tides on the Thames at Twickenham riverside caused minor flooding and the sewer works near the station were responsible for delays and diversions. But while the encroaching river water did little except cause a tidal wave and great entertainment for swans, the road closures by the Albany pub have much longer-term implications. Until June the area from Station Road and St. Mary's Terrace will be closed to traffic. This will mean delays for school traffic as well as for drivers taking a back street route to avoid congestion in Heath Road.



High Tide at the Riverside

Thames Water has provided local residents with detailed plans of the work which will take place in three phases running from 5th January to 11th June. For a significant period drivers will not be able to drive past The Albany when turning left or right from London Road. At the same time drivers trying to reach London Road from Station Road will find their way closed. Pedestrian access is not impeded. The work is to divert a main sewer to prepare for the development of Station Yard.

Helping Pierre to find his happy place By Shona Lyons



A few days ago I passed Pierre on my way to work, and I must admit I had not seen him that way before. He was unable to talk, unable to articulate himself, his face was red and he looked as if he was in a great deal of emotional pain. I tried to talk to him but he just told me he would talk to me later. Then he came into our office and he was agitated and telling us that he had problems with his landlords, they were evicting him because he had infringed their very draconian rules (like not using the toilet for god sake! And going back into his shop past 6pm! Or popping in when he shouldn't on a Sunday or Monday when he wasn't allowed) he infringed these rules maybe 3 times and he was told that he was being evicted.

His shop on Church Street as you can see from these pictures, has been Pierre's very happy place, even living under these difficult conditions. He is loved by pretty much every normal person, he is a bit eccentric in a very lovable way, wearing ridiculously funny aprons & head gear, and speaking his mind. He is just Pierre, with a good sense of humour and a very down to earth, easy going manner. He feeds all the neighbourhood dogs with his biltong, amuses everyone's kids who he loves, and sells biltong, sausages, meat and specialities from South Africa and every time I walk past pretty much, thrusts a big box of South African rooibos tea in my hand because it was practically the only tea my mum could drink when she was ill and he always gave me boxes for her as he has a very generous giving spirit.

His dad who he was very close to, died recently suddenly from a stroke and he just felt that everything was over. All he had built up, his good connections with this community, the love he had also put into his shop, as well as his savings doing it up and getting it painted and fitted out with lots of really nice South African tribal art etc, was finished and he just didn't have the strength to pick himself up again.

I came to work again yesterday and saw him sitting outside Barclays very upset. A fellow trader told me he had cut his wrist. He was obviously very distressed. I didn't see him again that day and had passed his shop and saw a messy note that he had scrawled letting people know he wouldn't be there that day. You see he is so nice, even in his distress he wanted to tell his customer -friends he wasn't there. Then later in the day about 12 midday I had a terrible video message on what's app from Pierre, saying he didn't want to live anymore. He had nothing to live for. He had lost his shop, his dad and had nothing left.

I know that I have been in dark places myself, and I am sure a lot of people have. Feeling that you have no one to turn to, problems that you can't deal with, no way out of a very difficult situation. I could totally empathise with Pierre. The thought of Pierre taking his life was just unbearable. I lost my mum recently & her death is incredibly painful. The thought of Pierre ending his life was just too much to bear. I felt I just had to do something & find him. I tried to text Pierre but he didn't answer, so I called him but he didn't answer. I called the police a few times but they said they couldn't help so then I put his video up on face book and twitter appealing for help to locate him. Then later that evening I remembered that I had his landlord's email and contacted his landlord and found that he had in fact returned home. Someone else in Church Street had his address, had seen the video I posted and also sent the police round to talk to him.

I think he understands now that we all love him and want to try and help him. I think the posts I put on face book alerted a lot of people about his predicament and he has had a lot more support and that is helping him feel he can cope again and with help, find a solution to his problems. The best thing was walking up Water Lane this morning and seeing Pierre with one of his suppliers looking at the empty shop in Water Lane. and seeing that he wasn't alone now with his problems and people understood and are trying to help. I have set up a Go Fund me Page and so far we are close to £2,000. I hope to be able to raise about £10,000 to put towards him being able to kit out a new shop, a place where Pierre can be himself and happy again.

Hollywood actor, Blake Lively's **Betty Buzz** range of new, great tasting premium soft drinks, recently launched in the UK, are a good Dry Jan solution. The Betty Buzz range includes Sparkling Lemon Lime, Ginger Beer and Sparkling Grapefruit. With 40+ awards and counting since launch, I'm told that **Betty Buzz** mixers are already one of the hottest products on the US alcohol-free market. From £2.50 per 266 ml bottle from Whole Foods Market and as a multiple pack from <u>Amazon</u> - 24 x 150ml cans from £29.99

Sometimes one wants something completely different, and I'm pleased to report that I've discovered an unusual range of aperitifs from **Drinks Kitchen**. There are three core products: **Orange Cinchona** (woody notes from cinchona & fruity orange followed by more zesty peel and herbaceous notes of quassia & oregano and a gentle bittersweet finish) Spiced **Rhubarb** (with aromatic juniper and ginger, and gentle chilli heat on the finish) and **Herb Verde** (an initial burst of refreshing mint with the pea pod notes of gentian, followed by more



subtle herby notes of rosemary & thyme). Plus a limited edition **Grapefruit Piquante**. They are really good, and have won stacks of Great Taste Awards. Each 950ml bottle makes 38 drinks or up to 7.6L of finished drink. £27 per 950ml bottle or £18 for a 475ml. Available online <u>here</u>



I was pleased to discover a couple of new alternatives to spirits at food festivals last summer. **WaveLength Drinks**. Another excellent aperitif discovered at a food festival is **Feragaia**, distilled in Fife, at Scotland's first 0.0% abv distillery. It's crafted from 14 land and sea botanicals, with the bonus of a long finish of pink peppercorn, and it's very refreshing and versatile. It's delicious served with ginger ale, or with grapefruit juice for an alcohol free Paloma. You can buy a 70cl bottle for £26.35 (also at Master of Malt and Not on the High Street) and in ready mixed cans <u>here</u>





I've talked before about the great range of aperitifs from **Pentire**, and the company now has a delicious ready mixed alcohol-free Margarita. A healthy riff on the classic Margarita, coastal botanicals, with lime, agave, sea salt and a dash of Mexican chilli, create a zingy, ready to drink, cocktail. Available in two sizes: 20cl bottle serves 2 and a 50cl bottle serves 5 online <u>here</u>. For the ultimate enjoyment, pour 100 ml into a rocks glass over ice and garnish with a lime wedge and a slice of chilli. You can also salt the rim if you like your Margaritas that way.The company also donates to selected sea conservation charities such as Blue Marine Foundation.

If ready mixed cocktails (and in particular an Espresso Martini) are your 'thing' then you don't need to stint on flavour. Try the range of the

world's first nitro non-alcoholic cocktails from **Mocktails**, The Official Cocktails of Dry January. Mocktails offers a range of mixology inspired flavours: the *Karma Sucra Mockapolitan; The Vida Loca Mockarita; Sevilla Red Sansgria; Scottish Lemonade Mockscow Mule* and *Espress0% Martini. Tanqueray Flor de Sevilla gin and its 0.0% Alcohol-Free spirit version are inspired by Charles Tanqueray's Andalusian adventures, that took him into the orange groves of Seville in the 1860's. The 0.0% also manages to balance the uniquely bittersweet and zesty taste of Sevillan oranges with orange blossoms, and the complexity of the core

botanicals from Tanqueray London Dry. It's readily available and well priced at around £15 a bottle.

If a liqueur is what's wanted, then try the **Giffard 0.0%** liqueur range. The Elderflower one is delicious, and has a host of other uses in desserts and cocktails too. Try a spritz, with low or no alcohol sparkling wine. Available

online <u>here</u> from The Whisky Exchange for £12.50 a bottle.

And now to **Mother Root**, a ginger switchel. The company takes inspiration from age-old methods of



aperitif wine making: maceration, blending and sweetening for balance. But rather than using wine, it uses benefit-rich apple cider vinegar and fresh, natural ingredients. WINTER GENERAL CREATURE-KINDNESS TIPS:

As I always say, the true key to our own happiness lies in the happiness of others...be they big or small life forms...

If you see a bird or any wildlife suffering at a roadside, throw over a towel or jacket over it and take to a local wildlife centre (pigeons are best reported to London Wildlife Protection as other places may put them to sleep without giving a chance. Squirrels, parakeets, even mice injured by cats can be helped). If you have rodent issues, consider humane live capture traps and release them in parklands. Try electronic high-frequency sound deterrents (check online for ones with good reviews and ones that are safe for your pets). Put empty jam jar lids filled with white vinegar to stop rodents without harming them (this also works for foxes and squirrels) Use a phone torch and leaf to picking up a slug off a pavement with a leaf and moving it over a wall (they feel pain too). Don't jet wash or sweep your garden patio too often as there are many tiny almost invisible hence I say gently lift the pots if you need to move them rather than dragging them to avoid crushing little lives). Expressing the art of the theatre critic

GLAD TO BE ALIVE The Unfriend by Steven Moffat

Playful Productions at Wyndham's Theatre, West End until 9th March

If you are nice, civil and very English, you'll understand the unfolding predicament in which Peter and Debbie find themselves in *The Unfriend*. On a cruise, they meet Elsa Krakowski from Denver. Holiday friendships are usually ephemeral, but ebullient Elsa is insistent, incessant and persistent and e-mails are exchanged. But, when they return home to their semi in suburbia, Debbie googles a Denver news item about the, albeit unsubstantiated, rumours about the serial "Killer at Large", Elisa Jean Krakowski.



However, Elisa has already invited herself to stay with them and their two teenage children!

Hence, we have the spring-loaded funny and furious plot of *The Unfriend*. Television talent is transferred to theatre from the co-creators of TV's *Sherlock*. Steven Moffat is a BAFTA winning writer, but *The Unfriend* is his first stage play, while the actor Mark Gatiss makes his debut as a director.

The arrival of Elisa is sudden. She is there at the front door! She had been planning to first



stay with Barnaby, a widower whom she had also just met on the cruise ship. Now, she has come directly from Heathrow, because he has suddenly died!

The play is a wonderful character study, an exposition of the crippling effects of niceness. Debbie and Peter are rabbits caught in the headlights of their own politeness. Ironically their dithering negativity is no match against Elsa's confidence. When they try to be assertive, they are not so sure. Is Denver on a witch hunt for someone they see as a busybody? Is Elsa a kind soul trying to do good, as she sees it? Or is she a murd... no, no, that's unthinkable.

Amongst the quick-fire quips, there are many incisive insights that really ring true. Guardian

reader Peter says, "I don't know what to think until I read about it." Celebrated comedian Lee Mack electrifies the role, his body language almost exaggerating the excruciating embarrassment of a man caught out by trying too hard not to be caught out. Sarah Alexander has the difficult role of his wife Debbie, a mum, protective of her children and trying to keep her husband from making a fool of himself as he attempts to defend the family against perceived threats.

The enigmatic Elsa is a gift of a role, and Frances Barber makes the most of it, playing it big, as it deserves. She interprets with insight both Elsa's acerbic charm, if that is not too much of an oxymoron, and equally her manipulative, yet would be benevolent, nature. Barber also knows how to pitch Elsa's non-sequiturs.

The two teenagers are acted with precision, painting pictures of awkward adolescent mulishness. Maddie Holliday plays the stroppy daughter Rosie, and Jem Matthews, the lairy video-game obsessed son, Alex. Debbie and Peter may be worried sick about Elsa, but they not only quickly become great friends, but Elsa manages to bring out the very best in the two youngsters. They become loving, helpful, active and positive.

Moreover, Elsa becomes quite a hit in the neighbourhood. Even the local bobby, PC Junkin, has become quite besotted with Elsa, and settled into the house in her behest. The trouble is, he has been sent around to inquire about the unexpected death of Barnaby. Then there is the lugubrious man from next door, The Neighbour: Peter never bother to find out his name. He has been



waging a low-level war of attrition about the rebuilding of their garden wall.

Under all its knockabout fun, *The Unfriend* is an inventive and insightful examination of human psychology. It takes us on a clever journey towards thinking, "Well, that's alright then" ... until its very end.

Embarrassment is a great moderator: "I'd rather die than be impolite". But would you?

The centre-forward put the west Londoners ahead in the first half, before Phil Foden equalised just before the break.

But Toney's 98th-minute strike was enough to take all three points home from Manchester just before the break for the 2022 World Cup, and was the first of two victories over City in the Premier League last season.



England Men's A Coaching Staff for Portugal Fixture Confirmed

George Skivington will head up an all-Gallagher Premiership line-up of coaching staff to lead England Men's A against Portugal this February.

The A side return after an eight-year absence for an encounter with Os Lobos at Leicester Tigers Stadium on Sunday 25 February, kicking-off at 13:00 GMT.

Skivington will be joined in the dugout by fellow Gloucester Rugby coach Dom Waldouck, who will lead on defence, whilst Northampton Saints' Sam Vesty will be in charge of England's attack.

Having retired from a successful playing career with Wasps in 2016, Skivington moved into coaching, firstly with Samoa in 2015 before working at London Irish as an assistant coach between 2016 and 2020. He was later appointed head coach at Gloucester Rugby in 2020.

The 41-year-old is no stranger to the England A team environment having captained the side on a number of occasions. He lifted the Churchill Cup in 2010, having also played in a 66-0 win over Portugal for the team in 2009.

Dom Waldouck accompanied Skivington in that convincing victory, scoring a try in the only previous meeting of the nations 15 years ago at Sedgley Park. The 36-year-old also has playing experience with the England U20 Men's team.

Former centre Waldouck has been a part of the coaching group at Kingsholm since Skivington's appointment four seasons ago and previously lifted the Heineken Cup and Premiership title as a Wasps player.

Sam Vesty, the current head coach of Northampton Saints, will lead the A side's attack. Vesty's Saints are currently top of the Gallagher Premiership table and the coach will hope to bring with him the attacking threat that has seen Saints top the Premiership's try-scoring charts for the last two seasons.

The 42-year-old knows Leicester well having played for Leicester Tigers 164 times, becoming the fourth member of his family to play for the club before moving to Bath Rugby where he made a further 64 appearances. The utility back retired in 2013 before taking on a coaching role at Worcester Warriors. Whilst at Sixways, Vesty was appointed skills coach for England's two-Test tour of Argentina. In 2018, he was named Northampton Saints attack coach before taking on the role of head coach in 2022.

The coaching team was chosen in consultation alongside Premiership Rugby, with the selection of the first matchday 23 since 2016 to be determined by senior men's head coach, Steve Borthwick, in due course.

Portugal will provide a stern test for England Men's A team after a strong showing in last year's Rugby World Cup, which included a draw against Georgia followed by a maiden tournament win over quarter-finalists Fiji.

Speaking ahead of the announcement, George Skivington voiced his delight in being confirmed as the England Men's A head coach.

"It's a massive honour to be asked by Conor (O'Shea) and Steve (Borthwick) to lead the England Men's A team next month. I recognise the trust they have placed in me with this opportunity, and I look forward to linking up with the coaching group and the squad in February.

"I'm delighted that Dom Waldouck will be joining me as defence coach. His passion for the game and dedication to his craft makes him an exciting young coach who I think will develop to be one of the best in the country.

"The England Men's A team will serve as a good opportunity for young English players on the cusp of international honours to show what they're about."

Sam Vesty said: "It's always a privilege and an honour to be asked to help support England, to wear a Red Rose on your chest and to compete at a high level, so I can't wait to get started.

"It's a great opportunity for me to work with some of the best young talent in the country. We'll be encouraging these players to go out and play what's in front of them, getting their eyes up and putting their best foot forward – both in terms of playing well in the game against Portugal, but also hopefully progressing on to further honours with England.

"It's a great learning and development opportunity as well for me to experience a different environment, working with different players and coaches, and I'll head into camp with a really open mind."

RFU Executive Director of Performance Rugby Conor O'Shea said: "On behalf of the RFU, I'd like to thank both Gloucester and Northampton, alongside Premiership Rugby, for their collaboration and effort in assembling what is a very exciting coaching panel ahead of our Men's A fixture against Portugal next month.

"We're fortunate to possess a coaching staff boasting a wealth of experience in the game that totals decades and will be a fantastic match for the appropriate challenge of Os Lobos.

"Each member of the coaching staff was picked with the consideration of their ability to develop young players and bringing international talent to the top of English rugby.

"This fixture, as well as the England Men's A games to come, aims to elevate that platform and build a consistent pathway for young English players into the senior level of the game in this country."
