Altered train services due to Rugby at Twickenham Saturday 26 April

London Waterloo – Shepperton

- Between 1041 and 2241, all Shepperton to London Waterloo services are diverted via Twickenham.
- Between 1142 and 2342*, all **London Waterloo to Shepperton** services are diverted via **Twickenham**.

London Waterloo – Reading

- Services will depart earlier from **Reading** through most of the day (at xx:05 and xx:35).
- Trains departing **Reading** between 1730 & 2230 will call additionally at **Putney and Vauxhall.**
- Services will also run later from Richmond to Reading before the match.

Altered train services and buses replace trains in the Barnes area Sunday 27 April

The lines in the **Barnes** area will be **closed all day** due to maintenance work.

Due to the diverted services, some services via Wimbledon will be revised.

- London Waterloo to Reading services will be revised and will be diverted between Clapham Junction and Twickenham. These services will call additionally at Wimbledon, Kingston and Strawberry Hill.
- London Waterloo to Windsor services will be revised. An hourly service will be diverted between Clapham Junction and Twickenham via Kingston calling at all stations.

An **hourly** service will start from **Richmond** calling at all stations.

- London Waterloo to London Waterloo via Richmond and Kingston services will be revised and will only run between Richmond and Kingston.
- Buses will run between Clapham Junction and Twickenham via Richmond. These buses will not call at St Margarets.
- London Waterloo to Woking via Staines services will start from Kew Bridge.
- The afternoon and evening London Waterloo to Kingston via Hounslow services will not run.
- Buses will run between Clapham Junction and Kew Bridge.
- London Waterloo to Hampton Court services will run hourly.
- London Waterloo/Wimbledon to Guildford via Cobham services will be revised and will start from London Waterloo all day.

Kilmorey Mausoleum - St Margarets By Alan Winter

Only one postcard this week and it is the only postcard I have ever seen showing the Mausoleum in St Margarets Road. I recently attended a talk given by Andrew JT George who wrote a booklet about the Mausoleum last year for the Habitats & Heritage Registered charity based in East Twickenham.

This is such an interesting story that I thought it deserved to be featured in this column although I have never seen another postcard on the subject. This particular postcard was published in 2022 by the charity after it was photographed by charity member Stephen Fielding. The same photograph features on the cover of Andrew's book on the subject which was published last year (2024). What follows is all taken from Andrew's talk and book on the subject for which I thank him.


The Kilmorey Mausoleum in St Margarets Road is a magnificent



example Of Victorian funerary architecture. It was originally erected in 1854 in the Brompton Cemetery for Priscilla Hoste, the young lover of Francis Jack Needham, the 2nd Earl of Kilmorey. It is 15-foot square made from the finest polished granite in the Egyptian style.

The Earl was a larger than life character, a patron of the arts, a keen rower and who had a predilection for buying large properties and renovating them. However, he is mostly remembered for his scandalous relationship with Priscilla, with whom he eloped in 1843 when she was 20 and he was 56. They lived together in a number of houses in Twickenham until her death in 1854.

After Priscilla was deposited in it, the mausoleum was moved twice, once to Woburn Park, his



residence in Weybridge and then to its current location on what is now St Margarets Road, close to his home in Gordon House. Francis Jack died in 1880. He was laid to rest in his coffin next to that of Priscilla in the Mausoleum.

The mausoleum was manufactured from polished Aberdeen granite, something that only became possible because of technological developments in the 19th Century.

It is an amazing story of how it was designed, made, transported and eventually landed under the care of Habitats and Heritage.

The charity is having a plant sale and open day at the Mausoleum on Sunday 11th May 10.00 to 2.00. The Mausoleum will be open to the public with a guided tour and no doubt Andrew's book and Stephen's postcard will be available to purchase.

The Royal Parks urges cyclists to slow down as it launches new cycling campaign

86% of Londoners think there should be a 20mph speed limit for bicycles

The Royal Parks charity launched a campaign today encouraging cyclists to be more considerate and to adhere to the speed limit in the parks in order to enhance safety and improve the park experience for all visitors.

The 'considerate cycling' campaign has been launched following several incidents in the parks and in response to a recent survey *, which revealed that almost three-quarters of London pedestrians (72%) had witnessed or experienced a near miss or collision with a cyclist.

The same number of respondents (72%) also stated that people 'cycling without due care and attention' was their main concern as a pedestrian. 86% of people believe the 20-mph vehicle speed limit in central London should also apply to bicycles, which are currently exempt.

The campaign is backed by a <u>new code of conduct</u> that all cyclists entering the parks should adhere to, regardless of whether they are commuting, exercising or exploring the parks recreationally. It is also supported by new signage that can be seen across the Royal Parks in high-traffic areas, and there is a new online hub on The Royal Parks' website for people who want to learn more about cycling in the parks.

The code of conduct provides best-practice quidance on safe cycling within the parks. It asks cyclists to:

- 1. Respect the park environment
- 2. Respect all park visitors
- 3. Control their speed
- 4. Know the rules comply with the Highway Code and Park Regulations
- 5. Be seen and be heard

The campaign, which will run through the spring and summer months, highlights the importance of creating a harmonious environment for cyclists and pedestrians. With an increasing number of people riding bikes in parks, it is crucial that cyclists adhere to posted speed limits and exercise caution.

Darren Share, Director of Parks, The Royal Parks charity, said:

"These wonderful urban green spaces are incredibly important to so

many people, but we all need to remember that they are shared spaces meant for everyone, and we must all play our part. Cyclists must understand the impact their speed can have on others, which is why it is crucial that they comply with the Park Regulations, and we are asking people to stay within the vehicle speed limits in the parks.

"The safety of all visitors is our top priority. By encouraging cyclists to slow down, respect the park environment and be considerate of others, we hope to foster a culture of respect and a safer, more enjoyable experience for all park visitors whether on two feet or two wheels."




CYCLING CODE OF CONDUCT

RESPECT THE PARK ENVIRONMENT

Be conscious of walkers, horse-riders, dogs off leads and wildlife. Cycling is only permitted on designated cycle paths and roads. At crossing points, cyclists should give way to vulnerable users, pedestrians, runners and where there is provision, those riding horse

RESPECT ALL PARK VISITORS

Pedestrians take priority over cyclists within the parks. When cycling, always be vigilant and ride in a considerate and alert manner. Slow down when approaching pedestrians and be patient and courteous. Cyclists should take particular care and consideration of others when cycling in large groups, and should break into smaller groups when the parks are busy.





Always be mindful of your speed, specifically noting the speed limits in force on park roads and trails. Do not ride in excess of 20mph in any circumstance and do not use the park roads for unauthorised competitive cycling of any kind. Reducing speed helps maintain a safe and welcoming environment for all visitors

KNOW THE RULES Apply the principles of the Highway Code when cycling in the Royal Parks. Familiarise yourself with the Park Regulations. These regulations set out specific offences that apply within the parks – including cycling outside designated cycle paths.



Always use lights in times of low light. When passing pedestrians, slow down and use hand or voice signals to indicate your intentions – when turning, slowing down or stopping. Do not shout at other park visitors. Be aware that some pedestrians may have visual or hearing impairments and might not see or hear you.

Richmond Council Hit by Fraud

Richmond Council is under fire after revelations of widespread fraud across multiple departments. A recent fraud report reveals that more than £1.47 million in losses and overpayments were uncovered in the past year alone. The South West London Fraud Partnership (SWLFP), which investigates fraud across Richmond and neighbouring boroughs, has warned that the risk of fraud remains "substantial" and continues to be the largest reported crime type.

The most alarming figures emerge from the borough's housing sector. Richmond no longer directly manages its social housing, having transferred responsibility to associations like the Richmond Housing Partnership (RHP). Yet the Council still bears the financial burden of temporary accommodation costs, which have soared to an eye-watering £4 million a day across London.

In the past year, 12 properties were recovered from fraudsters. Tenants were found subletting, living abroad, or abandoning homes entirely, denying legitimate families much-needed housing. The Council estimates a £93,000 notional saving for each home reclaimed — but these victories are few and hard-won.

A recent London-wide report, *Tenancy Fraud London 2025*, warns that detection rates have plummeted by 40% in a decade. Housing associations, now managing the majority of London's social homes, often lack incentives to police tenancies effectively. As long as rent is paid, fraudsters slip through the cracks.

But the problems don't stop at housing. Richmond Council's own departments have fallen victim to serious internal fraud. Five council employees were caught inflating overtime claims, stealing over £39,000. Three were sacked, and a report branded the council's systems unfit for purpose.

In another scandal, two officers colluded with developers of Houses in Multiple Occupation (HMOs), fast-tracking preferred landlords for temporary housing placements. Both resigned before facing disciplinary action, and the case is now with police.

From bogus parking permits to abuse of council tax discounts, fraud cases paint a troubling picture of a council stretched thin on oversight.

The Council claims it has a "robust anti-fraud culture," but the facts suggest otherwise. Surveillance powers under the Regulation of Investigatory Powers Act (RIPA) — once a key fraud-fighting tool — have scarcely been used in recent years.

This crisis is as much about policy as it is about enforcement. The decision to transfer social housing to associations may have streamlined operations, but it has left a vacuum in accountability. Housing associations face no direct financial penalty for fraud; councils – and taxpayers – foot the bill.

Fraud in Richmond isn't just a technical issue buried in committee reports. It's a moral failing, depriving local families of homes and draining scarce public funds. What's needed now is leadership – to restore proper oversight, demand accountability from housing providers, and invest in fraud detection before the cracks become chasms.

Richmond's Council's £38.8 Million Black Hole: Residents Face Hidden Cuts and Tax Hikes

Richmond Council is facing a £38.8 million budget black hole—but residents are being kept in the dark about the deep cuts to local services that may soon follow.

This week's meeting of the Council's Audit, Standards, and Statutory Accounts Committee laid bare the growing financial pressures. The Council's external auditors, Ernst & Young, have *been unable to sign off Richmond's accounts for the second year in a row*, due to a shortage of auditing professionals.

The auditors highlighted major errors in the valuation of council-owned buildings. Two schools, in particular, were undervalued by millions of pounds due to outdated information. Although these mistakes have now been corrected, the auditors still say they *cannot trust the overall state of Richmond's accounts*.

The £38.8 million budget gap is present in the medium term financial strategy. This shortfall is likely to increase further as the council has been holding back the latest cost estimates for the Twickenham Riverside Development. There has been growing frustration amongst councillors over this secrecy, who feel the senior members of the administration are trying to run away from scrutiny.

Behind the scenes, town hall officials are preparing for *severe cuts* to local services. Libraries, community centres, and day centres for the elderly are *believed to be at risk*. But the Liberal Democratrun Council is keeping these plans under wraps until after the May 2026 local elections—hoping to avoid a public backlash before polling day.

Due to these financial troubles, the Council continues to raise council tax at the highest level allowed without a referendum. This year's increase follows a string of above-inflation tax rises, pushing the burden ever higher for local families.

Meanwhile, the Council's financial reserves are running low. Richmond's *General Fund balance*—the money that can be used in emergencies—now stands at just £11.1 million. This represents 6% of expenditure and is at the lower end of the 5-10% agreed by the council.



That's enough to keep the Council going for only 23 days if the money runs out.

The Liberal Democrats have often attacked other councils in similar positions, calling them *"in crisis"* or accusing them of being *"close to bankruptcy"*. Yet now, Richmond is showing the same signs: widening deficits, shrinking reserves, and qualified audits.

All this in one of the wealthiest boroughs in the country. Richmond collects *one of the highest levels of council tax per household in Britain*, thanks to the large number of homes in the top council tax bands. Yet residents are paying more, whilst the council lets roads and pavements crumble.

For a borough with such a strong tax base, the question is simple: *how have the Liberal Democrats managed to let it come to this?*





St Margarets: The 'Geriatric Mother' Capital of the UK

St Margarets in Richmond upon Thames, with its tree-lined avenues, artisan cafés, and enviable proximity to the River Thames, has long represented a picture of middle-class comfort. However, beneath the postcard-perfect scenery lies a striking demographic detail: this affluent corner of southwest London is home to the oldest new mothers in the United Kingdom.

According to the latest data from the Office for National Statistics, the average age of firsttime mothers in Richmond upon Thames is now over 35 — the highest in the country. In St Margarets specifically, births to women under the age of 25 have become virtually nonexistent. It is not uncommon for women to start families in their late thirties or even early forties — a trend that has become so prevalent in the area that the term "geriatric mother," the medical term, if outdated and socially awkward, applies to a large number of residents.

There are clear reasons for this shift. One of the biggest drivers is the cost of living – or more precisely, the cost of housing. Richmond is among the most expensive boroughs in the capital, with average property prices comfortably exceeding £900,000. For many couples, buying a home suitable for raising children requires years of saving, career building, and financial planning. Parenthood, once something entered into in one's twenties, has become a milestone deferred until the conditions feel "just right."

For many women, this means spending much of their prime reproductive years pursuing higher education, building careers, and achieving financial security – all perfectly reasonable ambitions. However, while modern medicine has made later motherhood more viable, the biological clock has not kept pace with social change. Fertility begins to decline steadily after the age of 30 and more rapidly after 35. By 40,



natural conception becomes significantly more challenging.

As a result, many women in places like St Margarets turn to fertility treatment. Yet what is often underestimated is how physically and emotionally taxing these treatments can be. IVF, for instance, requires hormone injections, regular scans, surgical egg collection, and often multiple rounds before success—if it comes at all. The process can be financially draining and psychologically exhausting, particularly when it follows years of trying to conceive naturally. Some women also face the painful reality that no amount of medical intervention can guarantee pregnancy.

While much attention is often given to women's fertility and age, men over 35 also face declining fertility, although it tends to receive less public focus. As men age, sperm quality gradually decreases, resulting in lower sperm counts, reduced motility (movement), and higher rates of DNA fragmentation. These changes can complicate conception and increase the risk of miscarriage or certain conditions in children, including autism spectrum disorder.

Although men can technically father children well into later life, studies show that after age 40, the time it takes to conceive increases, and the chances of success with fertility treatments such as IVF decline. This highlights that fertility challenges are not solely a women's issue; advancing paternal age can play a significant role in a couple's ability to start a family.

These realities have attracted renewed public attention after a controversial statement from Bradford Teaching Hospitals NHS Trust. The Trust, in materials related to its "Born in Bradford" study, made a direct comparison between the risks of cousin marriage — common in some ethnic communities — and women over 34 choosing to have children later in life. Both, the Trust argued, are "cultural practices" that double the risk of birth defects in children.

The comparison has proved divisive. While both scenarios may involve increased risks, critics argue they arise from fundamentally different circumstances — and should not be equated. In St Margarets, older mothers typically have access to high-quality healthcare, private medical support, and prenatal screening — factors that can significantly reduce risks and improve outcomes. Moreover, late motherhood here often results from structural pressures, particularly housing costs, rather than being a lifestyle "choice" made lightly.

Nonetheless, the risks associated with later motherhood are significant. Women over 35 face increased chances of complications during pregnancy, including gestational diabetes, pre-eclampsia, and chromosomal abnormalities. While most women in this age group go on to have healthy pregnancies and babies, the process can be more complex and demanding than many expect.

The rise in older mothers across Richmond has coincided with an increase in the number of children requiring SEND (Special Educational Needs and Disabilities) support. Older maternal age is associated with a higher risk of developmental conditions such as autism and learning difficulties, which can contribute to greater demand for specialist education services. This growing pressure has placed Richmond's SEND provision under enormous strain, leading to a significant funding shortfall in recent years.

In St Margarets, the absence of young mothers is striking. The traditional image of twentysomething parents pushing prams through the park has largely been replaced by women juggling nursery drop-offs with Zoom meetings. This shift reflects broader changes in British society, where education, economic pressures, and social expectations are pushing parenthood further down the timeline.

The rise of the "geriatric mother" may be a product of modern success, but it also comes with trade-offs — not just biologically, but emotionally and financially. As public health officials seek to raise awareness about reproductive ageing, they must walk a careful line: respecting the choices and realities of women today while ensuring they have access to accurate information, support, and timely intervention.

In St. Margarets, where ambition and affluence go hand in hand, motherhood may come later – but it is no less desired. The challenge lies in ensuring that those desires are not met with avoidable heartache.



To whet your appetite, try one or two of these:

15-MINUTE GNOCCHI FISH PIE FEEDS 5

"I love fish pie and so do my family, but it's such a faff to make and creates so much washing up! This is a really easy, cheap version that is on the table in under 15 minutes and uses canned tuna, shop-bought gnocchi and just one pan!"

- oil, for frying
- 500g (1lb 2oz) gnocchi
- 1 onion, finely chopped
- 200g (7oz) garlic and herb soft cheese
- 2 x 145g (5oz) cans tuna, drained
- 100g (31/2oz) cheddar, grated
- 250ml (9fl oz) milk 80g (23/4oz) frozen sweetcorn
- 80g (23/4oz) frozen peas
- 1 tsp dried oregano
- 50g (13/4oz) fresh spinach leaves
- garlic bread and salad, to serve
- salt and freshly ground black pepper

TIPS & SWAPS

You can cook the gnocchi in the air fryer for 6 minutes at 190oC/375oF, if you prefer, before adding it to the sauce. If you want a crispy topping, sprinkle the finished dish with the garlic crumb from page 58. You can cook it in the same pan after you've fried the gnocchi.

Use reduced-fat soft cheese in this for a less rich option.



- 1. Heat a good drizzle of oil in a large, non-stick frying pan (skillet). When it's spitting hot, add the gnocchi (work in two batches if need be) and fry for 3–5 minutes over a medium–high heat until golden brown and crisp. Set the gnocchi aside.
- 2. Heat a little more oil in the pan. Add the onion and fry for 5 minutes until soft. Take the pan off the heat and add the soft cheese, tuna, grated cheddar, milk, frozen sweetcorn, frozen peas and oregano. Season with salt and pepper and return to a medium heat.
- 3. Stir until all the ingredients are combined and the mixture is starting to gently bubble.
- 4. Once the cheese has melted, stir in the spinach and the fried gnocchi. Simmer for a minute or two until the frozen veg is soft and the gnocchi is heated through.
- 5. Serve immediately with a side of garlic bread and salad.

20-MINUTE BEEF CHOW MEIN FEEDS 4

"This is a great Friday night dinner when you fancy a takeaway, but you're on a budget. The brilliant thing about chow mein is that it's easy to make taste just like the real thing! Serve this with spring rolls and prawn crackers if you want to go all out!"

- oil, for frying
- 600g (1lb 5oz) bag of mixed stir-fry vegetables
- 1 Tbsp cornflour (cornstarch)
- 4 Tbsp light soy sauce
- 1 Tbsp tomato ketchup
- 70ml (21/4fl oz) oyster sauce
- 500g (1lb 2oz) beef mince (ground beef)
- 300g (101/2oz) straight to wok noodles
- salt and freshly ground black pepper

TIPS & SWAPS

You can make this the classic way, by using thinly sliced chicken breast instead of beef. Use dried noodles if you prefer. Simmer 3 nests of noodles for 5 minutes in boiling water until tender. Drain and add to the pan. Swap the noodles for 2 pouches of

microwave basmati rice. Heat following the packet instructions before adding to the pan with the sauce.

- 1. Heat a good glug of oil in a wok or large non-stick frying pan (skillet). Add the stir-fry vegetables and fry for 5 minutes over a high heat, turning regularly, until soft.
- 2. Meanwhile, put the cornflour in a small bowl. Add the soy sauce and whisk with a fork until there are no lumps. Stir in the ketchup and oyster sauce and set aside.
- 3. Remove the veg from the pan and set aside.
- 4. Add a little more oil to the pan, if needed. When hot, add the beef mince and fry over a medium heat for 5 minutes, turning regularly, until browned.
- 5. Drain off any excess fat and return the veg to the wok. Gently pull apart the noodles so each one is separated, before adding them to the wok along with the sauce. Stir fry for 3–5 minutes over a medium heat, stirring regularly until the beef and noodles are cooked through and everything is coated in sauce. Season with salt and pepper and serve.

Nationwide unrest in the USA on the 250th Anniversary on the Declaration of Independence

Following the "Hands Off" marches throughout the USA last week, when over 500,000 Americans took to the streets against the Trump administration, another country-wide demonstration took place.

Last weekend Americans came out in their tens of thousands for the "No Kings" protest – No Kings in America, the weekend of the 250th Anniversary of the start of the American Revolution. It was reported that around 100,000 Americans marched against their president in 1,200 locations including outside the White House, the official residence and workplace of the

president of the United States.

I spent some time on X (formerly Twitter) on both the abovementioned occasions, watching the BBC News at the same time. The information on X gave an on-the-spot view of the situation in the USA, but no noticeable coverage by our public service television broadcaster at the time the protests were taking place.

It is of concern that one of the most prominent countries



in the world should be experiencing such dissatisfaction on the anniversary weekend of its independence, but our British television service does not seem to cover such momentous news at the time – and for two weeks running.

Protests were seen on X last Saturday, but this is just a snapshot of the situation in a country with fifty states - and Washington DC:

New York: thousands take to the streets to call for the end of the Trump regime; San Francisco: human banner of protestors spelling out "Impeach" "Remove"; huge demonstration in Houston; massive demonstration at Daley Plaza, Chicago; anti-Trump demonstration in Portland, Oregon; Protest in Buffalo, NY; massive protest at the White House, Washington DC; massive protest in Denver, Colorado State Capitol; thousands in mid-town Manhattan, "No Kings in America. Power belongs to the people"; Protest Ohio Statehouse; 300+ protestors in Franklin, Tennessee: thousands protest in Salt Lake City; more than a thousand protestors in St Paul Minnesota; anti-Trump protestors in Nashville's Centennial Park; protests in North Carolina and South Carolina; Rhode Island protest rally; Hundreds protest outside J.D Vance's house in DC; Protests in Colorado Springs; JD Vance confronted in Cincinnati, Ohio; Huge crowd of protestors in Hartford Connecticut; Phoenix, Arizona, protestors chanted "No Kings" and "Resist Fascism"; St Paul, Minnesota Hands Off protests; over a thousand protestors in San Antonio; Protests in Albuquerque, New Mexico and thousands of protestors in Anchorage, Alaska. Times Square was packed and protestors gathered at Trump International Hotel, New York.


Modern Warfare

At the time of writing there is no clear news about the "plan" for Ukraine.

On Friday this week the Mayor of Kyiv said on the news that Putin does not care about human life. This is clear when looking at the devastation, loss of life (on all sides) and suffering by the Ukrainian people who just want to live in peace.

The US president, Donald Trump, said he would end the war within 24 hours of being elected, but the weeks have gone on and so has the war. People, killed, maimed, buried and burned alive, and Ukrainian children abducted and taken to Russia. Donald Trump, the US president, the leader of the free world, now says the 24 hours promise was just a joke.

It has been reported on X that Russian authorities are extracting mineral resources from occupied Mariupol. Over 120,000 tons of Ukrainian coking coal has already been shipped from a local port; this coal, essential for steel



production, may be fuelling Russia's war economy. Russia destroyed Mariupol in 2022; thus, it seems from reports that valuable commodities have been taken from the area and used to continue aggression towards Ukraine.

Denmark, also has a concern about Trump's eye on Greenland's minerals and has made a request to invoke Article 4 of NATO, formally requesting consultation with allies. Greenland is included in the Council of Europe and NATO as part of Denmark.

In response to the situation The Netherlands King Willem-Alexander has said that the country must *"arm itself to the teeth"*.

Trump has now stated that the USSR has offered a "Pretty Big Concession" to stopping the war in Ukraine – the Russians will get Ukrainian land, but the "promise" now is not to take the whole of Ukraine.



Interview with David McGeachie on the release of his second album

Hello David, you are a well-known local estate agency owner, so how does music come into it? Well music's been there all my life – I started playing drums when I was 9 then guitar and bass etc then was in bands in Scotland for years before coming to London, where I worked for top record labels before leaving to work for myself 26 years ago. I started the estate agency in 2006, but all this time I was playing at jams and writing songs and then I decided to try and make something of that a few years ago after meeting music publishers that liked my songs.

You released an album a few years ago? Yes, my first one, 'Vendetta' and as I am fond of saying, it was the biggest selling local artist CD at Eel Pie Records shop, ever – mind you the previous one only sold 2! But it did well, and I was thrilled. It is all available on streaming too of course- Spotify / Amazon / iTunes etc

You call yourself David Anstruther for music – where does that name come from? Anstruther is a fishing village in Scotland where I spent all my family childhood holidays, so it has very happy memories and good feelings for me. I still visit it most years



Do you have a band or is it all, for example, acoustic?

It all sounds like a band playing but it is all me – drums, keys, bass, guitar - and I write it all and record it too. McPrince! The only other person involved is my friend Jovan who used to work in a top studio, and he masters it all for release.



What is the style of music and what are your songs about?

I suppose it is pop/rock – I believe in 'The Song' as a structure so I try to make it interesting musically. In terms of lyrics, they are about being me, being my age and being around here! A funny thing happened with my first album – I thought people would like the general lyrics, if anything, but they liked the most personal ones, funnily enough, so this time I went for it on that side, so much so that I've printed the lyrics on the CD cover and online. I like writing about

where I live so this time tracks include 'Eel Pie Island' and 'Naked Ladies' both of which already have people singing along at open mics, which is fantastic. On the first album I had a song called 'The Draw Off' which was about the River and that gets applause too which is amazing.

How do you write your songs? Lyrics first? Or tune?

Sometimes it's a title, or a tune comes into your head and it already has words attached that fit, so you then write the song about that, but a lot of the time I have a small list of lyric ideas lying around and I try to match them to one of the musical ideas that come up at another time and make them work together. I suppose my favourite song on the album is 'Eel Pie Island' and that came about as I was walking along the embankment one night. The chorus and its tune just came into my head. Just a song about the special island we all love.

Do you play live or are you more a studio person?

I love writing and recording and creating but I've always played live and with my own songs I play them regularly around here at open mics and other gigs. A hearty round of applause for a song I wrote myself is an incredible thing for me.

Who do you think might like your songs?

I suppose people my age mainly, age 50 and up. They are, I suppose, traditional pop/rock songs with lyrics from the perspective of someone my sort of age.

What is your ambition with your music

Well, that's a good question; I'm not going to be the latest pop star at my age. I just like the idea of being 'that estate agent guy who does music and some of his songs are quite good!' and have a group of people around here who like my stuff. And also, I'd love to get a song away as a cover - my music publisher and I have started submitting songs to major artists, when invited by their managers and producers, so it would be fabulous to get a song of mine recorded by someone well-known.

Will album number 3 come along?

Yes! I have dozens of songs and new ones keep coming too, so yes, will keep going; I totally love doing it.

How is the estate agency doing?

It's great thanks, still gradually growing after all these years and I have wonderful colleagues, so that's good and I love that too, but you have to have things outside work and the biggest item in that category for me is music and songs. My great uncle Alec in Edinburgh was playing guitar and singing live well into his 80s so if I can follow him in that way I'd be delighted.

Thanks, and good luck with the album Thanks v much indeed.



BROTHERLY LOVE? Tis a Pitty Shee's a Whore

by John Ford Richmond Shakespeare Society at the Mary Wallace Theatre, Twickenham until 26th April

John Ford's masterpiece of Jacobean theatre is not for the faint-hearted. A dark drama about sexual passion leading to despair, incest and revenge, director Rodney Figaro's production hurls itself at us from the start, but with absolute power and magnificence. The poignancy of love is shown in the physical relationship between brother Giovanni and sister Annabella which rises to supreme tragedy.

Ford takes a compassionate view of two young siblings, who discover a pure love, in stark contrast to the deceit and violence of the treacherous Italian court. He is not condoning incest, but expressing terrible pity of the waste of two young lives, the *Pitty* of the play's title. Figaro and his fine cast gradually steer us through the drama to its horrific climax with extreme skill.



Eric Petrossian is the mercenary Spaniard, Vasques, developing the lago-like personality with carefully-studied brilliance. Paul Smith and Roderick Ellis, as Bergetto and Poggio, keep the comedy scenes controlled, concentrating on their own ridiculousness until nemesis descends. Fran Billington plays Floria, Giovanni's and Annabella's mother as sensitive, sage and sensible. Although originally Florio, the female characterisation works well. Billington always excels in benevolent parental roles.

John Gilbert and Junis Olmscheid's costumes are thankfully true to the 1620's period, splendid brocade, velvet, tassels and pearls.

With its many wheeling characters, interwoven plots, and visceral violence, one comes out of a play such as this positively reeling, and with the tragic recognition that, whatever Giovannl's and Annabella's feelings are for each other, their love is doomed.



Honey Bees on the Move BBKA Beekeepers Ready to Rescue Spring Swarms

It's that time of year when honey bee swarms start taking flight across the UK. Swarming is usually limited to a couple of months but many may not survive without your help.

The UK charity, the British Beekeepers Association (BBKA), has launched its annual Swarm Savers initiative with thousands of trained beekeepers across the country on standby to safely rescue and rehome honey bee swarms completely free of charge.



While swarming is a natural and vital part of a honey bee colony's life cycle, up to 80 per cent of swarms perish if they don't find a suitable home - a statistic that underscores the urgency of public awareness and support.

With the growing threat of the yellow-legged asian hornet - a predator that can decimate honey bee colonies - supporting the survival and safe rehoming of these swarms has never been more important.

Commenting on the situation, Diane

Drinkwater, chair of the BBKA said: "There's something truly magical about witnessing a honey bee swarm. It's how a colony reproduces; a natural marvel where thousands of bees work together to protect their queen and find a new home. But without help, many never make it."

What should you do if you see a swarm?

Stay calm. Despite the noise and size, swarming honey bees are usually docile. Their main focus is protecting their queen and not hurting humans.

Keep a safe distance and do not attempt to move or destroy the swarm.

Correctly identify whether it is a honey bee swarm - if you're unsure, take a clear photo and contact a BBKA swarm collector. You can find identification resources <u>here</u>. Use the BBKA's interactive Swarm Map to locate a local volunteer swarm collector

Diane Drinkwater added:

"We know many people are fascinated or concerned by swarms but by knowing what to do, we can all help honey bees and make sure they're around for generations to come."

Honey bees are the only insect to swarm in the UK and the BBKA beekeepers are unable to help with the removal of the nests of any of the other more than 250 species of bees found in the UK.

Chancellor unveils plans to maintain level playing field for British business

British businesses will be supported to trade freely as the Chancellor chooses to act on practices that undercut fair trade, such as the dumping of cheap goods into the UK.

The government announced immediate action by the Trade Remedies Authority (TRA), the body responsible for defending the UK against certain unfair international trade practices. The Chancellor also announced her intention to review the customs treatment of Low Value Imports, which allows goods valued at £135 or less to be imported without paying customs duty.

Some of Britain's best-known retailers such as Next and Sainsburys, have called to amend the treatment, arguing that it disadvantages them by allowing international companies to undercut them.

Speaking in Washington D.C. at the annual IMF Springs meetings, Reeves was clear that an open global economy is crucial for UK growth, the number one priority of the government's Plan for Change. She said that free and open trade is good for the UK, but fairness needs to be injected into the global economic system.

Gains from global economic growth have not been equally shared both at home and abroad, and more needs to be done to tackle the rise in non-market practices that harm working people's incomes.

Chancellor of the Exchequer, Rachel Reeves, said:

"The world has changed, and we are in a new era of global trade.

"We must stand up for free and open trade – crucial to deliver our Plan for Change to make everyone better off. We must help businesses keep their access to trade around the world.

"This government is meeting the moment to protect fair and open trade. Following recent announcements reducing tariffs and support for the zero-emissions vehicles industry, today's package will help businesses compete fairly with international exporters, supporting a world economy that provides stability and fairness for working people and businesses alike."

Today's support comes in addition to recent action taken by the government recently to support industry and businesses navigate tough global economic headwinds. This includes action to protect British steelmaking, as the UK vows to take a strategic approach to the forthcoming industrial strategy so the economy that can make, sell, and buy more in Britain.


As part of the Spring Statement tariffs were suspended on 89 foreign products – ranging from pasta, fruit juices and spices to plastics and gardening supplies – over the next two years. The Prime Minister announced earlier this month that the Zero Emission Vehicle Mandate is changing to make it easier for industry to upgrade to make electric vehicles while delivering the manifesto commitment to stop sales of new petrol and diesel cars by 2030.

Business and Trade Secretary Jonathan Reynolds said:

"This government won't stand idly by while cheap imports flood our markets and harm British industries. That is why I met with the TRA recently to agree urgent steps to tackle these issues in real time to deliver quicker protections for firms. "This is about standing up for our national interest, and as part of our Plan for Change, creating a level playing field where UK businesses can thrive and grow."

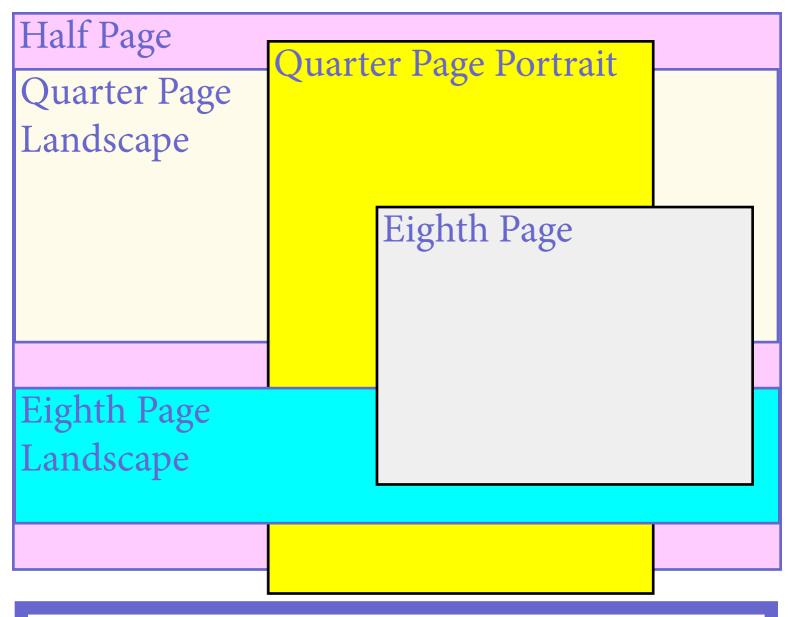
